This bulletin will arrive in your mailbox as we embark on another summer. Young birds should be all around, and the first southbound shorebird migrants will appear at Plum Island and Monomoy before the first week of July ends.

After 35 years as a member, this is my first president's message. It is an honor to take over leadership of our club. As president I hope to focus on strengthening our services to members and on citizen science efforts.

Two long-time members of the board stepped down this past April. Kathy Dia guided our pandemic webinar program, keeping us in touch with birds, birders, and ornithology during a difficult period. Barbara Volkle served the club in many ways over 28 years, including a term as president. We will miss their counsel and know we will see them in the field. The board has two new members – Abigail Young and our new Communications Coordinator Lara Kazo. We hope you will have a chance to get acquainted with them in the coming months.

Did you know that the BBC is one of the oldest, largest, and most active bird clubs in America? Founded in 1913, we offer over 300 field trips, webinars, and other events annually. The club got its start at the Brookline Public Library – hence the name – but has long drawn membership from across the broader Boston area. We now count over 1,100 members, including over 350 lifetime members.

Keeping our club vibrant means meeting the evolving needs of members. Over the past couple years we expanded our trip program by

partnering with other organizations, continued the webinar program that grew out of the pandemic period, reinstituted daytime pelagic trips, added a periodic newsletter in response to overwhelming interest expressed through our member survey, and held our first cooperative Big Day event on May 10th.

To that end we ran our first March Madness Membership Drive this year. Results are still coming in, but so far we have so many new members that we ran out of Blue Books to send them! We would appreciate

every member keeping us in mind when speaking to birding friends. Birding is for everyone and we hope to recruit from across the region.

What Federal Agencies Protect Wildlife and Habitat?

Environmental protection is a legacy and core value of the United States. It is reflected in the creation and funding of the following federal agencies.

- As the name implies the EPA, established in 1970, protects the environment through its research, environmental impact studies, environmental law enforcement, education, and any environmental protection matters.
- The Department of Interior, created in 1849, includes four major branches: the Bureau of Land Management (BLM, 1946), the US Fish and Wildlife Service (USF&W, 1956), the National Park Service (NPS, 1916), and the US Geological Survey (USGS, 1879).
 - BLM administers federal lands and resources
 - USF&W oversees the management of fish, wildlife, and natural habitats
 - NPS manages all national parks; most national monuments; and other natural, historical, and recreational properties
 - USGS science assists in decision-making related to environmental and resource management
- Aside from its well-known service forecasting weather, NOAA (the National Oceanic and Atmospheric Administration, 1970), a part of the Department of Commerce, manages fishing and protection of marine mammals and endangered species in US waters.
- Part of the Department of Agriculture (1862), the Forest Service (1905) administers 154 national forests and 20 national grasslands covering 193 million acres of land.

2026 Watchlist

On March 15th the 119th Congress passed PUBLIC LAW 119-4 (H.R.1968) to extend appropriations for FY2025. This law — again, passed —made *substantive cuts* to the EPA and the Departments of Interior and Agriculture.

Fast forward to May 2nd when the White House released its 2026 budget to Congress. As of this writing the bill is with the Senate. The following considerable cuts to federal spending are being proposed. *

Excerpts from H.R.1, One Big Beautiful Bill Act

- (Sec. 80101) This section establishes requirements about leasing onshore federal land for oil and natural gas development, including by directing the Department of the Interior to immediately resume onshore quarterly lease sales.
- (Sec. 80121) This section modifies provisions concerning the production of oil and gas from the Arctic National Wildlife Refuge (ANWR) in Alaska, including by providing for the reissuance of certain leases for energy development.
- (Sec. 80152) This section rescinds certain funding for the Council on Environmental Quality, including funding for (1) collecting data related to environmental and climate issues, (2) tracking disproportionate burdens and cumulative impacts,

and (3) supporting efforts to ensure that any mapping or screening tool is accessible to community-based organizations and community members

- (Sec. 80201) This section rescinds funding provided to NOAA that it uses to provide financial or technical assistance to coastal states and other eligible entities in order to enable coastal communities prepare for extreme storms and other changing climate conditions. The assistance may be used for the conservation, restoration, and protection of coastal habitat, marine habitats, and marine fisheries.
- (Sec. 80306) This section rescinds certain funding for the National Forest System, including funding for forest restoration, wildfire prevention, environmental reviews, the protection of oldgrowth forests, and related activities.
- (Sec. 80308) This section rescinds funding for certain conservation and ecosystem and habitat restoration projects on lands administered by the NPS and the BLM.
- (Sec. 80311) This section directs the Forest Service to annually enter into at least one 20-year or longer contract or agreement with private persons or other entities for timber harvesting in each of its regions for FY2025-FY2034.

The First 100 Days

These executive orders* and directives that pertain to CLIMATE were enacted in the first 100 days of the incoming administration, January 20th to April 28th.

April 28 Day 99

Dismissed all authors who worked on government's flagship climate report

April 17 Day 88

- Allowed commercial fishing in one of world's largest ocean reserves, Pacific Islands Heritage Marine National Monument
- Directed Commerce Department to loosen regulations that 'overly burden America's commercial fishing, aquaculture, and fish processing industries'

April 16 Day 87

Redefined 'harm' for endangered species making it much easier to log, build or drill for oil. Both USFWS and National Marine Fisheries published rules with a unified definition of "harm" to mean "an act which actually kills or injures wildlife."

April 11 Day 82

Called for elimination of scientific research division at National Oceanic and Atmospheric Administration

April 10 Day 81

Moved to end requirements at EPA that big polluters disclose how much carbon dioxide and other planetwarming gases they emit

April 9 Day 80

- Repealed Biden-era limit on water flow in shower heads
- Cut nearly \$4 million in funding for climate research at Princeton University

April 8 Day 79

- Threatened states' efforts to combat climate change
- Signed several executive orders aimed at reviving country's coal industry by expanding mining and burning of coal
- Cut funding and staff for a flagship climate report

March 24 Day 64

Announced EPA would take 31 deregulatory actions on environmental regulations

March 17 Day 57

- Aimed to eliminate EPA's scientific research arm
- Authorized production of coal-powered energy

March 12 Day 52

- Moved to repeal dozens of nation's most significant environmental regulations
- Canceled \$20 billion in climate grants

March 11 Day 51

Internal EPA memo noting all EPA environmental justice offices would be eliminated

March 10 Day 50

Pledged to reverse former administration's focus on undoing climate change

March 1 Day 41

Ordered an increase in U.S. lumber production

Feb. 20 Day 32

Reversed a freeze of some climate spending

Feb. 12 Day 24

Nominated an oil and gas advocate to run BLM

Feb. 11 Day 23

Started to roll back regulations requiring

companies to make disclosures about their impact on climate

- Ordered a review of EPA funding from 2022 climate law

- Instructed federal agencies to end subsidies for electric vehicles
- Declared a 'national energy emergency'
- Halted federal approvals for new wind farms
- Initiated plans to open up fragile wilderness in Alaska for oil drilling and mining

REPORTS

Brookline Bird Club 2024 Statistical and Year-End Report

- David Scott, Club Statistician

The Brookline Bird Club (BBC) recorded 283 species for 2024, with 274 species in Massachusetts (four more than 2023), and nine additional species reported from New Hampshire and Maine. This total was based upon 262 trips for which checklists were reported, the highest number in the history of the club, as well as the out-of-state overnight trips.

The two August pelagic trips visited Hydrographer, Dogbody and Welker Canyons and found a remarkable variety of marine life. This included four species of whales, three species of dolphins, three species of sharks, ocean sunfish, and leatherback turtle. One trip even managed to collect a baby sailfish from the sargassum. Bird highlights included White-faced, Bandrumped and Leach's storm-petrels, South Polar Skua, Long-tailed and Pomarine jaegers, Black-capped Petrel and migrating Red and Red-necked phalaropes.

Other highlights in Massachusetts included: Dovekie and Common Murre (Race Point, January 1), Western Kingbird (Salt Pond, Eastham, January 1), Longeared and Short-eared owls (Newburyport/Salisbury, January 1), Prothonotary Warbler (Mt. Auburn, May 1), Northern Goshawk (Westboro WMA, May 6), Chuckwill's Widow (Charles River Esplanade, May 15), Caspian Tern (Plumbush Marshes, September 11), Scissor-tailed Flycatcher (Ipswich River Audubon, November 16), and Spotted Towhee (Provincetown Airport, November 30). Outside of Massachusetts, Bicknell's Thrush, Canada Jav. Ruffed Grouse, and Boreal Chickadee were seen on

the trip to the Lake Umbagog region in New Hampshire. On the Rangeley Lakes and Downeast trips to Maine, the club recorded Spruce Grouse, Evening Grosbeak, Black Tern, Upland Sandpiper and Nelson's Sparrow.

Birds we missed in Massachusetts included Redpoll, Snowy Owl, Red Knot, Evening Grosbeak, Dickcissel, Yellow-breasted Chat, Ruffed Grouse, King Eider, Redhead, and Canvasback (last reported on a club trip in 2014).

There were 385 species reported in eBird in 2024 for Massachusetts, of which the club's total of 274 represented 71 percent. The club reported the most species in Essex County (226), followed by Plymouth (165), Middlesex (164), Suffolk (148), Worcester (141), Barnstable (130), Bristol (127), and Norfolk (126) counties. Trips to Mt. Auburn Cemetery recorded 113 species this year, including 29 species of warblers. We missed Blue-winged Warbler at the cemetery but recorded it on 15 other trips.

Thanks also to the organizations with whom the club co-sponsors trips. These include the South Shore Bird Club, Cape Cod Bird Club, the Charles River Esplanade Association, Massachusetts Department of Conservation and Recreation, Minute Man National Historical Park, and the Franklin Park Coalition.

Excluding the pelagic and overnight out-of-state trips, there were 363 eBird checklists associated with 259 trips. American Robin retained its position as the most frequently reported species, appearing on 261 checklists. Song Sparrow (252) and Blue Jay (248) remained in second and third. Mourning Dove (227) and Northern Cardinal (226) overtook Black-capped Chickadee (222). American Goldfinch (219) was seventh, and Downy Woodpecker (208) moved up two places to eighth. Mallard (209) was ninth and Redwinged Blackbird (193) tenth. The next five were Common Grackle (185), Canada Goose (177), Herring Gull (177), American Crow (174) and Northern Flicker (170).

A comparison with the frequency of species that the club reported 40 years ago reveals some significant changes to the birdlife of Massachusetts.

BBC's First Big Day

On May 10, 2025, the BBC initiated its first Big Day as part of Cornell University's Global Big Day. A Big Day is a 24-hour period in which the total number of species seen is recorded. Over 40 enthusiastic birders tallied a total of 186 species despite heavy rains throughout the region, establishing a new baseline for future events. See the details at ebird.org/tripreport/369262

Scientists consider it important to measure the number of species in a given period to assess the impact that climate change and loss of protective measures has on bird populations. Our club has significant records that illustrate changes in bird populations within our own cherished birding areas.



Join us to hear a talk by Amar Ayash, author of The Gull Guides. Amar joins us to talk about his favorite group of birds — GULLS. Gulls are sometimes perceived as second-class avian creatures. They present identification challenges and have a readiness to hybridize; this could explain why many birders have a love-hate relationship with gulls.



Yet some gull species are among the most coveted birds on any birder's list (think Ross's Gull and Ivory Gull). This makes for an interesting juxtaposition. Do we like some gulls and look past others?

Amar Ayyash will take us through an entertaining and intriguing exploration of the natural history of gulls, including their thorny taxonomy, and he'll share some of their lesser-known adaptations and quirky behaviors.

We stress the importance of good public relations. When attending trips, please be considerate of residents and locations. Park away from driveways and well off the road. Never block a road or gate (ticketing and towing may result). Respect guidelines at locations such as those at cemeteries and wildlife refuges. Don't enter private property without permission.

Please be a constructive participant. Pay attention to the leader. Help the group locate and identify birds. Be considerate of others in the group. Don't go ahead of the group (you may spook birds before others see them). If you want to chat, drop back out of hearing range. We

encourage you to read our code of ethics on the BBC site for a refresher on responsible birding.

Some locations have entrance fees, and we note this in the trip description. At National Wildlife Refuges, we remind you that duck stamps or prepaid interagency passes will allow free entry.
